House Bill 64 - Budget Bill

House Bill 64 – The substitute budget bill introduced by the House appears to be much more palatable for rural districts such as ours. In Governor Kasich's initial proposal the budget bill expressed a desire to provide resources for the districts most in need and put a heavier burden on those that could reportedly bear the weight. The mathematical calculations, however, demonstrated that large city school districts were the ones who benefitted the most – at the cost of funding to small rural districts. In effect, the application was almost exactly opposite of the theory. The revised version from the House incorporates a funding model where the majority of districts in Ohio see at least some increase and, reportedly, none of them face lower funding in FY17 than in FY15. Outside of the scope of funding, it appears that the bill seeks to clarify many previously established rules, revise others, and introduce a few new measures with the presumable intent to improve education. Unfortunately what has transpired is that the legislation continually makes tweaks to the goals and rules and, subsequently, puts the onus on the Ohio

Department of Education to continually update and revise the same for schools. In a never ending cycle of change it has become apparent that the environment which has been created is one in which there are no experts. From someone who never shies away from change, this environment of constant change is certainly not conducive to school improvement. We have – and continue to – share our frustration with the legislators and, if you are so inclined, we would urge you to do the same. Hopefully the positives in this budget bill will withstand the test of legislature and time and provide schools with some good news from Columbus!
