Healthy Restart 2020-2021

It was the hope of Cory-Rawson Local Schools to release our Healthy Restart Plan for the 2020-2021 school year today. Unfortunately, that will not occur. Although hours, days, and weeks have been devoted to planning, the collaborative work taking place between Hancock Public Health and the school districts in Hancock County (including Findlay City Schools) is taking a bit longer than expected. It is my hope to present the final draft of the Hancock County/Findlay City Schools Common Re-Opening Agreement to the Cory-Rawson Board of Education for consideration during a special board meeting on Tuesday, August 4, 2020 @ 7PM. This document will address the following topics:

**Transportation, Arrival & Dismissal, Food Services, Recess, & Other Components of a School Day

**The agreement may or may not contain guidance related to potential student and/or staff illness related to COVID-19 or otherwise as recommendations continue to evolve over time. If the agreement does not contain this information, it will be released ASAP.

The Cory-Rawson Board of Education, as elected representatives of this district, will determine our district's commitment to this agreement. Based on the board's action, the district will prepare for the start of school on September 8, 2020.

While this delay may be frustrating, it is only happening as a result of careful planning and collaboration in an effort to responsibly begin the 2020-2021 academic year. 
