Whereas Ohio Revised Code 3313.6110 requires the Cory-Rawson Local Superintendent, as our designee, to certify and sign a document that the parents/guardians have complied with Ohio Revised Code 3321.04 A(2) and

Whereas the Cory-Rawson Local Schools believes this places our school in the position of approving a child's education under the auspices of our school and

Whereas the Cory-Rawson Local Schools believes that Ohio State Board of Education has developed these rules and should be the certifying agent

Be it therefore resolved the Cory-Rawson Local Schools hereby denote their opposition to this requirement and implore the legislators and the State Board of Education to reconsider the unfair impact and burden this places upon local school districts.
